SECTION 4: First Aid Measures

4.1 Description of First Aid Measures

General Information:	If exposed or concerned: Get medical advice/attention. If you feel unwell, seek medical advice (show the label where possible. 4.2 Most Important Symptoms/Effects, Acute and Delayed

4.3 Indication of Immediate Medical Attention and Special Treatment Needed

SECTION 5: Firefighting Measures

5.1 Extinguishing Media

SECTION 6: Accidental Release Measures

6.1 Personal Precautions, Protective Equipment and Emergency Procedures

Keep unnecessary personnel away. Keep people away from and upwind of spill/leak. Wear appropriate protective equipment and clothing during clean-up. Avoid breathing mist or vapor. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ensure adequate ventilation. 6.2 Methods and Materials for Containment and Cleaning Up

Large Spills: Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Cover with plastic sheet to prevent spreading. Absorb in vermiculite, dry sand or earth and place into containers. Prevent entry into waterways, sewer, basements or confined areas. Following product recovery, flush area with water.

Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.

Never return spills to original containers for re-use. For waste disposal, see Section 13 of the SDS.

6.3 Environmental Precautions

Avoid release to the environment. Prevent further leakage or spillage if safe to do so. Avoid discharge into drains, water courses or onto the ground. Inform appropriate managerial or supervisory personnel of all environmental releases.

7.1 Precautions for Safe Handling

Obtain special instructions before use. Do not handle until all safety precautions have been read and understood. Provide adequate ventilation. Avoid breathing mist or vapor. Avoid contact with eyes, skin, and clothing. Avoid prolonged exposure. Do not taste or swallow. When using, do not eat, drink or smoke. Pregnant or breast-feeding women must not handle this product. Should be handled in closed systems, if possible. Wear appropriate personal protective equipment. Wash hand thoroughly after handling. Avoid release to the environment. 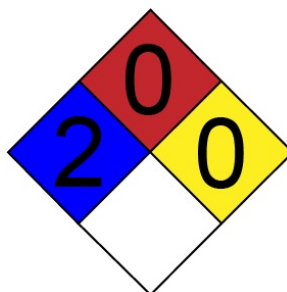
