SECTION 4: First Aid Measures

4.1 Description of First Aid Measures

General Information:

If exposed or concerned: get medical advice/attention. If you feel unwell, seek medical advice (show the label where possible). 4.3 Indication of Immediate Medical Attention and Special Treatment Needed

SECTION 5: Firefighting Measures

5.1 Extinguishing Media

Suitable: Water fog. Foam. Dry chemical powder. Carbon dioxide (CO₂).

Unsuitable: Do not use water jet as an extinguisher, as this will spread the fire.

5.2 Specific Hazards Arising from the Chemical

The product is combustible, and heating may generate vapors which may form explosive vapor/air mixtures/ During fire, gases hazardous to health may be formed.

5.3 Advice for Firefighters

SECTION 6: Accidental Release Measures

6.1 Personal Precautions, Protective Equipment and Emergency Procedures

Keep unnecessary personnel away. Keep people away from and upwind of spill/leak. Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Wear appropriate protective equipment and clothing during clean-up. Avoid breathing mist or vapor. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ensure adequate ventilation. Local authorities should be advised if significant spillages cannot be contained. For personal protection, see Section 8 of the SDS.

6.2 Methods and Materials for Containment and Cleaning Up

Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Keep combustible (wood, paper, oil, etc.) away from spilled material. Prevent product from entering drains.

Large Spills: Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Cover with plastic sheet to prevent spreading. Absorb in vermiculite, dry sand or earth and place into containers. Prevent entry into waterways, sewer, basements or confined areas. Following product recovery, flush area with water.

Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.

Never return spills to original containers for re-use. For waste disposal, see Section 13 of the SDS.

6.3 Environmental Precautions

Avoid release to the environment. Prevent further leakage or spillage if safe to do so. Avoid discharge into drains, water courses or onto the ground. Inform appropriate managerial or supervisory personnel of all environmental releases.

7.1 Precautions for Safe Handling

Obtain special instructions before use. Do not handle until all safety precautions have been read and understood. Keep away from open flames, hot surfaces and sources of ignition. When using do not smoke. Avoid breathing mist or vapor. Avoid contact with eyes, skin, and clothing. Avoid prolonged exposure. Pregnant or breast feeding women must not handle this product. Should be handled in closed systems, if possible. Provide adequate ventilation. Wear appropriate personal protective equipment. Avoid release to the environment. Store locked up. Keep away from heat, sparks and open flame. Store in a cool dry place out of direct sunlight. Store in original tightly closed container. Store in a well-ventilated place. Keep in an area equipped with sprinklers. Store away from incompatible materials (see Section 10 of the SDS).
